Description:

Excel Fibermulch II hydraulic mulch is a natural, wood fiber mulch that provides an organic cover to protect seeds, enhance germination, and hasten re-vegetation when mixed with water and applied with hydraulic mulching equipment. Excel Fibermulch II is furnished with Dri-Water Hydro Mix Tackifier and green dye (optional without tackifier or dye) and is available palletized in polyethylene bags for applicator convenience. Excel Fibermulch II shall be manufactured in the U.S.A.

Excel Fibermulch II has a design soil loss ratio (event-based RUSLE C factor) of \leq 0.50 and is typically suitable for slopes up to 4H:1V. Excel Fibermulch II improves germination by \geq 200% (ASTM D 7322).
